

The OVCRD, through the Office of Extension Coordination, is now accepting applications for Extension Load Credit (ELC) for the Second Semester AY 2020-2021. Due to the pandemic, we will continue using the *Google* form. **All applications must be submitted electronically**.

Please take note of the following reminders:

- 1. Application A faculty member must apply for ELC using Google form <u>https://bit.ly/ELC-online-form</u> and email the copy to his/her Department/Institute for evaluation and pre-assignment of the load credit. **The** *Google* form will be open until 05 March 2021 only.
- Evaluation The ELC Google form application is evaluated based on the College/Unit's extension agenda. The Department/Institute should submit a summary of the pre-assigned ELC to its College on or before 19 March 2021.
- 3. Recommendation– The College evaluates and recommends the ELC applications. A **complete list of ELC faculty applicants** is electronically signed and submitted to OVCRD at elc_application_oec_ovcrd.upd@up.edu.ph., on or before **26 March 2021**. (see Annex A for the template)
- 4. Endorsement and Approval The OVCRD, through the Office of Extension Coordination (OEC), checks the complete list and validates the responses from the Google form. The VCRD pre-approves all ELC applications and will submit a **master list** to the OC through OVCAA for approval.
